Resolution - Cllrs voted in Favour to close the meeting to allow the public to address the Council, the meeting was duly closed at 18:20

Cllr Lawson explained in a conversation with Cllr Waltham MBE it was stated that strategic planners have recognised with the Barton Lorry park and the Barton by pass there isn't a need for another site of this type of site now.

Cllr Munn – highways did say they did not support the access.

Cllr Wells – Explained that the decision to be made is if the Parish Council and residents are in support of Local Plan Amendments and not current Lorry Park Planning Application.

Nigel Nutting (resident) – stated that other side (EC 1 – 8) hints further developments including the lorry park.

c) **To agree Barnetby Parish Councils consultation response and any further comments or clarification.**

Cllr Wells – Response should state that the land is re-allocated or used for any other site other than farm land / open countryside

Cllr Munn – Stated that when accidents occur in the area the traffic quickly backs up and Barnetby Top enables the traffic to continue to flow via diverted routes traffic. The Employment site would add congestion to the area and as the area is also on the Viking Way it is a popular site for walkers therefore the removal of this site is supported.

Other concerns raised:

- Road safety if the employment site was to remain
- The whole roundabout needs to be looked at under a full reconstruction at present the site is not justified
- The safety at Barnetby a18 is debatable at present, to put one access in at one side is possible, but to but both in is not in the interest of traffic safety.
- Roundabout is the main entrance and exit to the village you can end up being trapped and unable to get home easily.
- Busy enough already and very narrow.
- Parish Council should strongly support the amendment to remove EC1-7

**Resolution** – Clerk to submit the following comment to the Local Plan Portal:

*The parish council strongly support the amendment to remove EC1-7 as this site is completely unsuitable for the purposes of any development.*

*The parish council and residents in consultation would support that the site is completely removed from the local plan and not used for any other developments and is retained as Farm land / Open countryside.*

*The site is not suitable for employment in the interests of traffic safety, it is important that the area remains free flowing for traffic when accidents occur on the M180.*

*Traffic can often back up in all direction from M180 and A180 – using Barnetby top as the diverted route Adding further congestion to this in the form of employment site or the presently proposed lorry park is not supported.*

*In relation to EC1-7 and EC 1-8, two employment sites / business parks would not be favourable.*

Cllr Lawson MBE re-opened the meeting at 18.57  
The vote for the response was recorded:

3 in favour – Cllr Lawson MBE, Cllr Wilson and Cllr Munn  
0 against  
2 abstentions – Cllr Wells and Cllr Knill

Cllr Lawson MBE reminded the public that the Parish Council comment will only be classed as one comment, therefore public urged to submit their own comments.
