Barnetby in Bloom – Discussions had re planting of Trees in the Recreational field, the group are to send the tree numbers Cllr Waltham MBE and he will support the request.

Over 75's uptake of 4th Vaccine continues to be strong one of the highest in the country, although the uptake of over 5's is quite slow.

NLC have been Shortlisted to access multimillion pound pot for families facing challenges, NLC are guaranteed as one of 75 councils to receive some of the fund.

The £150 back for Council Tax Bands A-D with Direct Debits will be received on 2nd May. Of the 9000 people not on direct debit at the announcement of the refund, over half are now signed up to Direct Debits.

New initiative to provide additional support for people living in a bigger home and have low income - discretionary household fund.

Changes to bus route with Hornsby's Merging X4 now called the 4.

Police Anti-Social Behaviour meeting with Jim Munn (Barnetby - Neighbourhood Watch), online invitation has been circulated to Parish Council if they want to attend.

Traffic Regulation Orders – Site meeting has been arranged with the Parish Council on 3rd May.

Sink Hole – Anglian water are to undertake another piece of camera work believe the issue has been caused by a collapsed drain.

Traffic Enforcement Officers, one ticket issued in Barnetby for parking on Yellow Lines.

Over 100 Ukrainian refugees have been referred for housing within North Lincolnshire for up to 6 months.

Planning further discussions / desciosn need to be had to agree the format for the Planning Meeting – The Head of Planning for NLC is ready to address the Parish Council.

Cllr R Waltham MBE advised that the Parish Council should not close the meeting down to the public.

Cllr T Lawson MBE responded asking if the above that Cllr Waltham MBE advised is correct, can it be explained why Cllr T Lawson MBE received an invitation in March 2022, from Anya Snow inviting him to a meeting by Anya Snow, with the Ward Cllrs and Chris Barwell (NLC Lead Planning Officer) with no members of the public?

Cllr R Waltham MBE gave no further response.

Cllr Wilson stated that the News Items with Andrew Percy MP litter pick at Barnetby Top mentioned the Parish Council Chairman, this was NOT Barnetby Parish Council.
Cllr R Waltham MBE advised it was Elsham Parish Council.

The Parish Councillors raised concerns about Marsh Lane activity. The Ward Cllrs agreed to

Footpath from Barnetby to Wrawby is still unusable – will works be conducted to re-instate it?

Cllr R Waltham MBE advised it is being looked at but subject to feasibility study.

Cllr D Wells also mentioned the Gallows Wood layby to Barnetby is a good footpath but in need of scraping to clear.

Cllr T Lawson MBE asked if a member of the public can ring the council 7000 number and be put through to an officer?

Cllr R Waltham MBE – advised that the contact centre ensures that messages for officers that are not office based – i.e. Highways, Neighbourhood and Environmental Services etc can be logged and your calls returned.

Cllr Waltham MBE also advised that if residents are having difficulties contact NLC or getting matters resolved then the Ward Cllrs can be contacted or the Parish Clerk both of which will have access to NLC Officers.
