The group celebrated its success this year by having a meal together at the Whistle and Flute. A good time was had by all!

Having had the go-ahead from the PCC to clear and rejuvenate the Church car park entrance, we obtained a report from Dave Mitchell, our local tree surgeon, a copy of which has been given to the Chairman and to Lee Gabel. I shall be talking to the vicar about the recommendations after Christmas, when he is less busy.

At our last meeting, we discussed using some of our budget to buy a few more mature trees each year to be planted around the village, and in the playing field. We also want to apply for more free trees from various conservation agencies. We felt this would improve ecosystems and reduce the risk of flooding if planted in the correct places. We have enough money left in our budget to plant some this winter, which is the best time to plant bare-root trees. We will be having another meeting in the New Year to discuss this in more detail. May I finish by thanking the Parish Council for the support they have given us this year. It is much appreciated.

Jim Munn – Neighbourhood Watch – Not too much to update, a few weeks ago a white van caused some attention as the plates did not match the vehicle. This was reported and the vehicle was removed. Continues to be suspicious activity in the layby on Melton Ross / Bigby Rd – NLC has requested closure of the layby as it is self-made and not serving a purpose.
