Minutes of the meeting of Barnetby-le-Wold Parish Council held at 7.15pm on Monday 15th February, 2016 at the St Barnabas Church Hall Barnetby.

Public participation

Residents raised the following issues regarding the proposed closure of Kings Road during the roundabout construction and the proposed diversion.

- The proposed diversion was along very narrow roads that were badly potholed at the sides.
- 4 incidents in a week had been noted where cars had had to change their wheels due to the pot holes.
- The businesses based in Barnetby would have to send all their trucks through the village, noted that there is a 7.5t weight limit at Bigby. Offer made to drive RB/NLC through the diversion in HGV.
- Emergency vehicles would have to use the diversion.
- Would Knabs bridge be able to cope with the increased traffic.
- Lorries turning out onto the A18 need to use both sides of the road.
- The roads around Prospect Farm frequently freeze.
- Traffic speeding on A18 Melton Ross, poor visibility.
- Had possibility of putting a temporary road in at top of Kings Road been explored to at least let traffic out one-way.

RB/NLC noted all the above concerns and would discuss with Highways and report back.

Resident raised issue regarding dog-fouling, possibility of siting a camera in school alleyway. Community Wardens had been in attendance but had not caught anyone.
