Minutes of the Monthly **Parish Meeting** of Barnetby-Le-Wold held on **Monday 20th October 2014** in St Barnabas Church Hall at 7:30

The Clerk opened the meeting and requested the Council elect a Chair for this meeting from those present as both the Chair and Vice-Chair are unable to attend. The Council elected Cllr T Lawson MBE as Chair.

- 2. Declarations of Interest:** Cllr Bowness all matters on Village Hall and planning **application PA/2014/0987** Change of use from agricultural building to a dwelling
- 3. Approval of Minutes of 15th September:** Carried as a true record.

- 5. Chair's report:** Not in attendance as his train was unavoidably cancelled
- 6. Clerk's report** Previously circulated and accepted
- 7. Ward Councillor's reports:** Apologies from Cllr C Sherwood and R Waltham, Cllr Nigel Sherwood updated as follows:

Drainage Scheme: Cllr Munn requested information on any potential planning for the Deborah yard as she felt this was likely and asked if they would be held accountable for a contribution for the drainage scheme.

Recycling Centre: Cllr Beacroft requested information on the works at the recycling centre and Cllr Sherwood advised that 3 cameras have been put in place to track vehicles using the facility these have vehicle number plate recognition software to ascertain whether they are residents. The purpose of this is to identify how much neighbouring County Council should

be contributing to NLC for using our recycling centres. Cllr Wilson requested further information on the cost of putting the cameras in and the details of charging mechanism, Cllr Sherwood responded that the policy had not yet been finalised.

Skeggar Beck: November 20th Cllrs will be walking the Skeggar Beck to understand better the general condition of it and the next drainage meeting is on 21st November. Anglian Water has not yet attended the meeting. The clerk was requested to contact the Chief Executive Officer of Anglian Water to request an attendee at the next meeting: Carried

Railway Bridge: Problems with a lorry hitting the railway bridge earlier today have highlighted that the height signage is not consistent on both sides but this would not have prevented or caused the accident as the lorry was over by 1m in height.

There were 37 speeding vehicles in less than an hour through the bridge and traffic officers are dealing with this matter. Cllrs advised the high quantity of mud on the roads at this time with harvesting and Cllr Sherwood advised that is a Police Matter.

Singleton Birch: have put a planning application in for moving many 1000's of tonnes of materials which would equate to one lorry every 4 minutes building in passing places and managed by a Stop/Go worker. NLC are objecting as are Melton Ross. Clerk was asked to enquire why we as a neighbouring authority have not been consulted.
