Minutes of the Monthly meeting of Barnetby-le-Wold Parish Council held at 7.15pm Monday 17 October 2016 at the St Barnabas Church Hall Barnetby.

In attendance : Rachael Reddin Clerk, and 6 members of the public.

Public Participation Albert Newberry wished to raise the ongoing planning objections for PA/2016/1219 Removal of Condition 4. It was advised that that this matter is no longer something the Parish can comment on and advised Mr Newberry to seek further assistance from North Lincolnshire Council Planning department.

Wendy Brumpton wished to seek advice as to whether the barn at the end of marsh lane has applied for planning permission for change of use. WB advised that this has gone from a derelict building to a fully modernised building with a water supply. She felt that this should have required some level of permissions. The Parish agreed to pass comments to North Lincolnshire Council on her behalf.

Maria Monks wished to speak on a number of items, the issues with the roundabout and debris left over from the contractors – MM was advised this is agenda item 1610/010 of tonight's meeting. She then raised the parking concerns throughout the village and was advised that parking concerns and requests for double yellow lines was an agenda item last month and actions are still ongoing. 




