## 1801/013 Urgent Highway Matters and Updates

POTHOLES - the Parish Council wished to raise concerns on a number of incidents where the contractors that were instructed to complete pothole repairs have left the site unfinished and to a poor standard – it was noted that it was not identified that these were NLC workers if was believed that they were sub-contractors to NLC.

Woodland View / St Barnabas Road - there are still numerous marking on the roads where the contractors that visited before Christmas have not returned the edges of the Potholes have not been sealed. It appears that the repairs will not withstand much wear and tear before they begin to re-appear.

Gallows Wood Layby - The litter and debris at this site is very concerning, the owner reported colleting 3 bin bags full of little from just around her café, she also reported noticing Rats in this area too.

Commuters parking at the layby is still an issue, it was also raised that cars are also parking at the top on kings roads causing damage to this area of grass.
