## **1711/003 Ward Councillor's report**

Ward Cllrs advised that the consultation summary should be sent to NLC Highway who will take account of the comments raised

Cllr Lawson wished to raise his concerns with the Ward Cllrs, over the fire evacuation procedure witness at a recent event at the Baths Hall Venue Scunthorpe

On Friday 17 November 2016 Leslie, my wife, and I went to see Lulu - All about the Music at the above venue; our seats being B21 and B22 in the Balcony (Right Area). During the interval announcements were repeated - "we have to evacuate the building through no fault of our own go to your nearest Fire Exit". Bleep Bleep.

With many other people from the Balcony audience we did as instructed and endeavoured to make our way to nearest Fire Exit sign. Having passed through the first doorway, we saw the second Fire Exit sign on the left and we, as did others, turned towards this Fire Exit sign. However, a female member of Staff shouted out "you cannot go that way as that Fire Exit door is locked" and redirected everyone in the opposite direction. On questioning why this

second Fire Exit door was locked she stated that she didn't know and had no key for it. This obviously caused great concern to people some of whom were getting very upset about that nearest Fire Door being locked. At the third set of Fire Exit doors another female member of Staff was found to be holding one half of the Fire Exit double doors closed stating that everyone had to go through the one door left open. This obviously showed down the evacuation. Everyone from both sides of the Balcony had to walk down the same main staircase at least two abreast which, because of the amount of people, was a slow procedure. On arrival at the Main doors we had difficulty in getting safely down the steps as people were congregating on the steps and pavement. There did not appear to be anyone advising people where to Muster and there did not appear to be any Muster signs for people to read. When we exited the Main doors we were shocked to discover that the invalid slope on the left-hand side of the Hall was still blocked off - allowing no-one to leave by that exit. There was approximately 1000 people huddled on the steps and within 10 metres of the large glass doors and windows. If there had been a bomb explosion inside the Hall casualties could have been extremely high. The evacuation certainly took a lengthy time and, in my opinion, was not helped by the obvious lack of emergency training displayed by members of Staff.

I rang and informed the Leader of the Council who thanked me for the information, making our way home rather than congregate on or near the steps to the Hall in the cold, possibly impeding emergency services. I did see individuals being allowed to return and retrieve items from their seats.
