School – Planning permission has been submitted for a classroom extention at St Barnabas C of E.

Waste – NLC have been having a few issues with missed bins recently, this has been due to vehicle breakdowns. This issue seems to have been rectified now.

Marsh Lane – NLC have been collating numerous amounts of evidence against the new occupants at this site and is now in the process of issuing a Stop Notice on the site.
