Public Participation

D Adams – Made reference to the Winter in Bloom grant information as to what to apply for and commented that timings in which NLC have asked for bids are not great timing Villages need to plan the winter arrangements in the summer. Friend Of Barnetby Station – DA commented that there is still no further information about the embankment licence and stated that until we have a way forward with the embankment there will be little interest in generating a Station group.

Refrigeration works Marsh Lane – Environment agency response leads to believe that the Marsh Lane site is not licenced. DA stated that he felt the activities at the site should be licenced and urged the PC to take further action.

W Broughton wished to comment on the plans for bollards at the end of Silver Street, as by installing bollards or yellow lines the side of one stop, will cause issues with the 6:30am deliveries as cars regularly park on the corner blocking access for delivery wagons– if bollards are there then there will be greater issue – Chair advised that this will be discussed during agenda item once the meeting is opened.

WB also requested a new Dog Bin half way down Marsh Lane where Public Footpath crosses the lane.

It is believed that ONGO are taking no action to improve the area and it has been reported by Fire and Rescue Chief that emergency services would not be able to get down in an emergency services cannot get down, and there are reports that patients in ambulances need to be carried by stretcher down the street.

Vehicle parking under railway bridge – proposal was made in 2017 by NLC for the lines to be extended under the bridge. Clerk will chase this with NLC highways

- f) Dog Bins – Chair surveyed 13 bins / one off St Barnabas road looks worse – solid but unattractive – Proposal to NLC would like all to be replaced as some of them have nothing to indicate that they are dog bins. Proposal for additional bin on Marsh Lane—15 /20 L Clerk to check that NLC will empty, Red plastic on Marsh Lane area. All in favour - APPROVED
