#### Public Participation

KICKS - PA/ 2019 / 192 - Slight modifications are minimal caution need to be exercised when consideration of this application. The proposal is still a large industrial sized building.

LUCAS – Updated that the application has been discussed previously 25 Feb 19 – amended drawing supersedes the proposed garage – revision to roof. This reduction is only reduction of 10%, the ridge of the roof 8.5m above lane level and 2.5 meters higher than original cottages.

BRADER – applicant of PC/2019/192 – Location is in-line with current cottages, the use of the building Is for caravan housing. Similar height of similar cottages 14% less in ground area. Planning officer has verbally confirmed that NLC will support this application. Highways have no objections. English heritage D –listed the cottage as a pair of humble cottages that are beyond economical repair.

W Broughton – asked if the replacements / repairs to the Dog Bins can be chased up as well as the 30 mph signage on Church Hill.

D – ADAMS – access embankment / litter bins along the embankment area – Network Rail meeting attended – Pot of money we can bid for £50.000 community rail partnership – increasing footfall to the station, Planters etc The assumption that the parking would be free was untrue and there is parking condition of the Licence agreement stating the parking was always going to be Pay and Display. An action plan put together by CRPS, this includes suggestions on toilet facilities signage – this will be published on Barnetby PC website.

Cllr D Wells - Suggested some of the funding if obtained could be used to plant flowers on the embankment.
