Considerations to be given to Highways / subway flooding.

Factors in favour of the development is the need more families into the village, affordable housing allows families to grow in the village and supports the economy to grow.

Proposed response from Parish Council as follows:

"Whilst the Parish Council not opposed to the development it was the view that they would like to the concerns over sustainable and affordable housing to be addressed the housing must be apriority in this development and consideration appropriate off road car parking spacing.

Historical Planning was pass for a pond in that area, so must be water table? Flooding concerns in the village subsequently more drainage adds more water to the underpass which regularly floods."
