Parish Councillor Questions:

Cllr Lawson MBE - Meeting referred to was prior to the recent PC meeting, we have been effected by heavy downpours since that meeting, NLC response to the Parish Council request for a futher meeting was met with concerns to why we required a meeting with the flood team, prior to the planning committee meeting on 18th December 2019.

Cllr Lawson MBE continued to express concerns over the flood risk for Barnetby and PA.2019 1454 - Pump handles 173,000 per hr on average runs at 60% peaked at 90%. New application will put two more houses on it. There is still water on woodland view, in woodland view the dry pond is still not dry. Pipe is still too low. Still water coming out of the Keigar builders sump.

Keigar information on the application form states it is not on flood plane – Cllr Lawson MBE expressed that Barnetby Le Wold is a flood Plane area.

2 parishioners that have been to R Waltham offices are very very concerned in the builders ability to put a system that will support the flooding issues.

Cllr C Sherwood advised that the outcome of the meeting held with the residents, stated they are happy with the information they are being told.

Cllr R Waltham MBE summarised that the outcome, the application is not yet determined and intived Cllr T Lawson to a discussion with North Lincs Officers prior to the planning committee Cllr Waltham agreed to set up a Joint Conversation to be held on 17 December 19. Cllr M Wilson asked what the officers recommendation – Cllr Waltham advised it is to grant full permission but with a range of conditions assigned to it.

Cllr Lawson MBE – Expressed points made earlier in relation to the high flooding risk with this proposed development, Cllr Lawson MBE explained the amount of water coming out pump is under pressure from water coming from the field. Water table is further up than NLC think it is. 60% of time the pump is on 5mins on 3 mins off on a float which does not alert anyone, build up with no back up.

Cllr Lawson proposed that the Parish Council send an urgent letter for attention of the Planning Committee expressing that have changed since the Parish Council placed a neutral stance decision in Sept 2019.

Changes in climate saw 2 severe downpours of water – current system has not been able to cope, evidenced by the water being bowsered away.

Until Barnetby Le Wold has a safe effective current working system we would not want to put any further pressure on the without an ineffective system, by the additional two properties.

1 in 100 year event TWICE put the current system under considerable strain, RW alluded to that fact in 1995 there was no condition to provide any drainage, builders complied with the recommendations. Proposal to send a letter to NLC expressing recommendation that the planning committee not to pass any further planning until the current system is repaired – with a further recommendation that any gravity fed drainage system must be of a nature that is self-cleaning.
