



d) Kings Road Parking Issues


Cllr Wells declared a personal interest in this item

Council discussed the parking is dangerous currently and with the introduction of the new train to London direct from Barnetby parking issues will increase.


Proposal – Cut out some of the Kerb, remove some of the grass similar to the cut out on the Bakers Lane side.
