Cllr M Wilson proposed that meetings should resume from September with the meeting being conducted both face to face and remotely to ensure that all councillors and members of the public have to opportunity to attend in the current circumstances

Cllr M Swallow proposed and amendment for the Council to subscribe to a premium videoing conferencing package to ensure the meeting length is enough to cover the meeting duration Resolved to Approve the amendment

Cllr Wells proposed that Cllr Beacroft and Cllr Knill are advised to attend the meeting or request that an extension to their absence as the 6 month rule is still applicable during this pandemic – Resolved to Approve

Cllr Lawson MBE proposed that the AGM is postponed to May 2021 as per the government legislation changes which stipulates – Local authorities can decide not to hold the legally prescribed annual meeting. Where a local authority does not hold an annual meeting, current appointments will continue until the next annual meeting of the authority or when the local authority determines.

Cllr Wells proposed an amendment that in light of the AGM postponement that the agenda item for September is that Parish Council formally elect a chair as currently the Council is operating with a Vice Chair as acting chair and therefore no vice chair can conduct the meeting in the absence of the acting chair.

Amendment fell 2 votes in favour, 3 vote against
