Barnetby in Bloom Budget – carried over £101 last year to date there is £917 remaining for this financial year, it has been agreed this will be used towards the purchase of more railing planters

Winter Planting scheme to be commenced soon

There has been an idea suggested that Youth Club or school can come up with a theme for the design for the Railing area near to the embankment and the Bloom Group will help the design to be created.

Cllr Wilson stated that the area being discussed has been adopted by North Lincolnshire Council, it may be worth a discussion with Cllr Waltham to see if this can be visually improved / maintained.

D Adams also stated that there is a £5000 Community Rail Partnership TPE Grant funding will be used to fund improvements to platform planters, landscaping works, installing a bike rack and new signage directing people to Public Toilets.

Ideas suggested for a New Sleeper boarder at the Public Toilets – discussions that a sub-contractor may be instructed to undertake the works .

Parish Councils wished to ensure the salt bin is not removed from the location if any works should be undertaken.

Also Darren wished to express that Barnetby in Bloom Group are still looking for volunteers.
