Concerns also raised about the narrow passageway – this will cause a number of problems during the construction and after with refuse trucks as there is not enough turning space for large vehicles. It was also raised that it seems there are too many houses for the size of the plot.

2103/004 Ward Councillors Report

- a) To receive North Lincolnshire Council Ward Councillors Report

Cllr R Waltham MBE updated that the grant application for the Spring in Bloom has been awarded to Barnetby Le Wold, a total of £500 has been awarded for the In Bloom initiatives.

North Lincolnshire Council (NLC) has set its budget since the last Parish Council meeting, NLC have been able to give 2% increase older people and people with complex needs care and support. An overall 1.8% general council tax increase has been applied.

NLC continue to protect free car parking, pensioners concessionary travel, Library services and Library buses protected.

More money has been allocated for flooding and highways works.

South Humber Bank and free port status has also now been granted, there will also be a Customs site in Scunthorpe which will be beneficial for steel works.

Vaccinations continue to go really well in the region, into the 50+ and complex needs residents, from Friday 19th March will be opening of new mass vaccination centre.

A new Lateral flow site has opened in Brigg, this will support smaller employers with 2/3 employees.

NLC are also responding to a number of Planning and Streetlights enquires.

Cllr S Knill – requested an update regarding the draining gully across the house in woodland view.

Cllr R Waltham MBE – Responded that no update as yet, Cllr Waltham will follow up and requested Cllr Knill to email pictures through for information.

Cllr Lawson MBE updated that an Extraordinary Meeting was called on 10 March 2021 to receive the responses from NLC in respect of the Flood Alleviation Scheme. Cllr Lawson MBE expressed concerns that no firm answers given and the Council still has a number of questions unanswered.

No NLC Officers were in attendance at the Extraordinary meeting and this gives feelings to the residents that Barnetby Flooding concerns are not important.
