N Shoot gave a verbal update on the KCOM engagement plan, KCOM are currently rolling out across North Lincolnshire – they are now seeking to obtain if there is a demand for the Full Fibre broadband services in Barbetby Le Wold.

Cllr B Baker – what is the actual costing for the building of the infrastructure and will this cost residents?

NS confirmed that there are no cost to residents for the installations of the infrastructure – however to ensure that KCOM does invest in Barnetby the they would request residents to pledge to join using the voucher.

Cllr M Wilson – if sign up to the pledge are you committed?

NS – Yes if the demand is seen through the pledges then a minimum contract requirement – this is all detailed within the terms and conditions when pledging a voucher

Cllr H Munn – How long will it take and what is impact to residents

NS it will be a brand new infrastructure that will need to be laid, there will be disruption to roads and footpaths and they will need to dig small trenches in footpaths to install. This will take a few months to install.

The Beck Under the railway in 2007 the flooding came through hit the bank and flooded the properties – we have been asking for a 90 degree bend o be connect under the railway to turn the direction of flow so turns the water away.

None of the requirements were placed – but concrete on bank side MJ will look at and try to take them to task on site.

Changed the waterflow on Kings Road now runs through the railway. needs the 90 degree bend.

Long standing Prospect Bend – visited and no one turned up, logged recent flooding. Soakaway.
