- National Bus Strategy - Online bus survey in progress closing date 30 Sept 21. We would encourage all individuals to log in and have their say in this strategy.
- Relaunch of Tradewatch scheme, residents will be receiving a letter through door and will be given a sticker for windows. This has been proven as a good deterrent and it is encouraged to take up the scheme.
- Barnetby Top Development –we were aware of the proposal from Yarbrough Estate and under the NLC Local Plan this area has gone through consultation and has been identified as a potential employment site.

Cllr Waltham MBE emphasised that this does not guarantee that planning will be approved and assured the Council and public that there is a long way to go before the application for development can be submitted. NLC has been very clear of the criteria required prior to application.

Cllr Waltham MBE also ensured that if the application is submitted then the application WILL be called in to be heard at the planning committee.

- A major bin review across North Lincolnshire is being undertaken – this will include litter and dog bins NLC Dog Bins – waste is being explored as co-mingled (general and dog waste together).
- North Lincolnshire Council have launched the Independent Living Team – these can be contacted on 01724 297000
- COVID Booster jabs – NLC are aiming to link with pharmacies to assist in the roll out (currently being offered to over 70's and complex conditions) this will help to relieve the pressure over GP appointment for vaccinations. Where eligible the Flu jab and COVID 19 will be offered at the same time.
- Mini Roundabout Victoria Road and St Barnabas requested for white lines re-painting.
- Tree Planting season – NLC are seeking to work with communities to plant trees.
- Platinum Jubilee – Small grant for community events will be launched in due course.

b) To consider any questions or actions arising from the Ward Councillors Report.

Cllr H Munn – raised concerns that the developers for the Barnetby Top Interchange proposal sound very confident at the consultation session that the planning hurdles have been addressed with NLC?

Cllr Waltham Response - All people/landowners have the right to apply for planning on their land, however the right to apply does not mean that planning will be granted. As stated previously the application process has robust criteria requirements.

Cllr D Wells – Commented that the Highways expert that attended the consultation with the developers have got it wrong in the past.

Cllr T Lawson MBE – stated that the biggest concern is the effect on the whole village of Barnetby Le Wold of the traffic between the two roundabout with the ingress and egress lorries. It has already been witnessed at Immingham that HGV drivers stop to let other HGV drivers out – this will cause increased delays / congestion for motorists leaving or entering

Cllr Wilson raised a concern on behalf of a resident - On Friday 10 Sept 21 a parishioner contacted NLC planning department in respect of the demolition of the building at the old Deborah Scaffolding site as the area contains asbestos. The resident reported that the demolition was not being conducted inline with removal of asbestos regulations.

At the point of the phone call the telephone operator advised the resident to say site safety was ok.

Since then it has been confirmed that area did contain asbestos and no safety measures were in place. Cllr Wilson that it reported that items were being dropped at height and there was lots of dust present. No residents were advised to keep windows shut etc prior to the demolition work.

Cllr Waltham MBE advised he would contact Cllr Wilson outside of this meeting to obtain further details.

Cllr S Knill asked for an update on the Speed Bumps at Brigg Recreational Ground.

Cllr Waltham MBE updated that the football club were not in favour of the proposal. The area will remain a priority for the Neighbourhood Action Team (NAT).
