Public participation

Resident 1 – Raised issues relating to Skegger Beck running very fast, amount of water is undermining the bridge over to the landowner field

Marsh Lane – where the building site is it is thick mud on the lane. Verges have been ripped up, which is starting to break the road up. Dangerous for walking.

Residential Caravan there is no planning permissions and should be removed.

Resident 2 – wanted to raise concerns about the planning application a) PA/2021/2273 for a Lorry park. Concerns around the heavy amount of water and pressure onto Skegger Beck. Kiegar as the Riparian responsibility – not upholding their responsibilities.

Resident 3 – in response to comments around Planning Laws - Local Authorities can deviate the laws and also questioned why NLC is not a signatory to the climate emergency declaration.

Cllr C Sherwood updated that the Planning application for the Lorry park does sit within Melton Ross Parish and at the last Parish Council meeting they passed No Objections.

COVID continues to take a large proportion of councils time – we have one of the highest vaccinated people across the country.

Vaccines to become available for 2 – 11 years old.

Amendments are being made to the Just Go bus services to create more capacity

NLC have invested in 20 electric scooters to enable people to access work and transport through the Wheel to Work Scheme.

Highways state they are continuing to monitoring the sink hole Silver Street

Prospect Bend site visit held and a Co-op meeting to improve Skegger beck maintenance/

Neighbourhood police surgery will take place on 28th Feb 3-4pm - near to the One Stop.

2202/005 Chair's & Clerks Report - To receive an update on items from the previous meeting.

Clerk updated on actions since previous month

Cllr Lawson MBE advised that a meeting of Prospect Bend was held on 3rd Feb 22 as promised

It was made known to the Parish Council that two pipes have been put underneath the road that are 150mm. Outflow on the crown of the bend have reinforced on the bank and on the other needs more re-enforcement.

The problem seems to be resolved and there is no sign of water.

Cllr Lawson MBE expressed much admiration for North Lincolnshire Council Officer Mick Johnson – he has been very pro-active and attentive to a number of issues raised.

CONSULTATION EXTENSION GRANTED UNTIL 23 FEBRUARY 2022

Resolution -Following a lengthy discussion with Council and members of the public the Council passed a motion of OBJECTION to the application based on the following reasons:

1. Barnetby has great concerns of excess surface water finding the way from the lorry park through the strata (clay layer), and into Skegger Beck, please note - Skegger Beck goes into the Ancholme which as of 21.02.22 is currently flooded due to the heavy storms.
2. NLC currently have 3 Lorry Park planning applications, in Barton upon Humber – in which we believe there to be no major concerns or objections, a Planning application for a Scunthorpe Lorry park, therefore is there a need for the Barnetby le Wold application, which will see a destruction of countryside.

3. We do not think the site will create sufficient employment as the site is currently intended for within the North Lincs Local Plan.

4. Road safety – access in and out on the proposed plans will create serious traffic concerns in all directions, we also note that Highways England have some serious reservations for this factor also.




