Resident 1– as resident of Silver Street there are ongoing issues and concerns and nothing ever seems to get done despite reports to North Lincs Council. Urgent matter of the road sinking, there is a water leak in the street for over a year, pot holes are a mess and the road has sunk further. 4th and 11th November phone call from highways arranged for sink hole to be fenced off which is now an obstacle with one stop shop deliveries

There is also a dark blue transit illegally parking, hard to gain safe access to the road - possible head on collisions

Resident 2 – Public Footpath near to the new co-op site has it been closed by the contractors. Network rail blockage / contact the contractors Illegal what they were doing. Bank of the beck in places has been taken away.

Resident 3 – No Litter bins (Victoria Road, St Barnabas Road, Near the Railway, Walkers Close – smashing bottles).
