Camera facing Silver Street, who monitors it?

The CCTV is part of the NLC Safer Neighbourhoods Team, it is not monitored all the time and will looked at upon request. The continuation of the camera installation subject to review.

Parking on Junctions namely St Marys Avenue and Silver Street - the parking within 10 meters law only applies at night. If it not causing a visual obstruction road, not parked in dangerous position then enforcement action will not be taken. It is not an offence to park on a pavement but it is an offence to cause an obstruction.

Cllr Baker - re: Silver Street parking is a concern as young children are often around the area and the cars and dangerous parking does are obstructing views.

PCSO - every road is dangerous, due to the number of issued are raised in Silver Street, the area is monitored on every shift.

Cllr Munn - A lot of general public don't really know what the police do and don't do anymore, and can often be quite disappointing when people are reaching out for support.

Barnetby seized 3 motorcycles, seized car in Brigg for no insurance.

Silver Street – advice, education and engagement approach before enforcement.

Confirmed that the CCTV facing Silver Street has been requested to be extended into the summer.

Thanks to all involved in the Ukraine efforts in the village. Number of people contacting us for taking people in from Ukraine, however please be assured that many checks need to be carried out prior to NLC accepting refugees such as Domestic Abuse, Child Sexual offences etc.

Car on Silver Street was removed following Parish Councils and resident feedback at the last meeting.

£150 Council tax grant A-D those with direct debits will get the money on 1 May 2022. NLC will be in touch with people that do not pay be Direct Debit.

Amendments to Household Recycling Centres (Broughton and Barton) effective 1 April 2022 following criticism that people have to go into Scunthorpe on the days the rural sites are closed, the changes now ensure residents can go to Broughton or Barton on rural closure days.

£90,000 secure to support the most vulnerable, approx. 1200 people on pension credits / council tax rebate given £375 to pensioners on lowest income.

No further updates on the Lorry Park application Cllr Waltham MBE confirmed their position still remains the same we do not support it (Cllr N Sherwood excluded PPI).

In response to the resident comment last month NLC have not signed the Climate Emergency declaration, due to the heavy industry within our area (i.e the steel works) therefore any measure that would need to be imposed would be unachievable and we have a duty to protect jobs in heavy industry.

Possibly via a cheque.

Issues surrounding Marsh Lane, the illegal Caravan and the state of the Lane need to be addressed.

Cllr Lawson MBE asked - Ward Councillors support to change planning laws via Andrew Percy MP?

Cllr Waltham MBE advised to set up a meeting with Chief Planning locally what we need to change in terms of the law. Could seek to resolve in the final round of the Local Plan rather than via MP's.
