2205/004 Ward Councillors Report

a) To receive North Lincolnshire Council Ward Councillors Report

Cllr Waltham MBE – Updated that a Neighbourhood Watch meeting with the Police meeting with Jim and Helen Munn, was productive as a whole.

NATS meeting Thursday 19th May at 6pm

Marsh Lane – Planning enforcement involved, Business rates, Commercial Waste and Licencing etc all been notified.

Over 100 Ukrainian Refugees now approved to arrive in North Lincs.

Vaccination rates continuing to rise, 55 % of over 12's have now had a vaccine.

Government Household Bills - £150 council tax paid to most residents approx. 40000. Letters will be sent to those who are not on Direct Debit this week.

Silver Street – Anglian water still undertaking works – possible may need a road closure – prior notice will be given. Cllr Waltham MBE ensured this is on their Ward priority list for resurfacing.

Bakers Close and Kings Road potholes also reported.

Resident email – really pleased with waste operatives about how the followed the highway code when passing a horse rider.

Attended the Highways meeting with Cllr Baker held on 3rd May 2022.

b) To consider any questions or actions arising from the Ward Councillors Report.

Cllr Baker asked of the waste operatives get recognition personally – Cllr Waltham MBE confirmed that yes the crew did receive the feedback.

Cllr D Wells – asked if possible to have 2 reps for NATS. Cllr Waltham MBE advised that the Neighbourhood Watch lead needs an invite, but might be useful to contact Danny Marsh re: Parish Council Reps.

The Parish Council fed back comments from members of the public in relation to Marsh Lane.

Cllr Waltham MBE – Law enforcement, MUST keep reporting. Planning enforcement cannot comment on individual cases. Unfortunately, the criminal proceeding process does not happen overnight. However to re-assure the council and residents the processes are being followed and it is important that this process is followed to ensure that the right measures are taken from the outcome. It is important to manage expectations for complainants, it is reasonable in Law – if somebody has broken planning laws are allowed to apply retrospective to remedy it with planning.

Cllr Waltham MBE confirmed that the site is not allocated for any other use than its current use – not in the local plan to change the usage of the site.

Cllr Baker asked if clarity can be obtained on the Hatcheries site - Cllr Waltham MBE confirmed to obtain this.

Cllr Lawson MBE – asked in respect of the Silver Street Road Closures, will Pedestrians will be given access and proposed that could the Road Closure be started on the weekend to give people chance to find alternative parking spaces. Once the notice of closure is served then the Clerk can confirm these dates with NLC.

How many of the 150 Ukrainian individuals are living in properties mainly living with other families and how many properties have NLC purchased - Cllr Waltham MBE confirmed that the council have not purchased any properties as Council is not a social landlord so do not own any housing.

Allotments – The Parish Council would like to advice on how NLC can support in obtaining land for allotment – a site has been identified, can a grant be awarded for these purposes.

Cllr Waltham MBE confirmed that Grants have previously been awarded for allotments, the process is to obtain 3 quotes and develop a project plan.

Cllr Lawson MBE updated that the Council are in discussions with a Barnetby Landowner in respect of a piece of land available for allotments.

Clerk updated that NLC are supporting in discussions with NLC in respect of supporting the land purchase. A number of aspects are being explored in respect of the land such as – Access, planning requirements, possible encroachments and rear access claims of adjoining owners, suitability of ground for allotments etc

Cllr D Wells – advised that a Community Grant could be explored and Goxhil have recently been successful in obtaining land for allotments.
