The In Bloom application of £2375 grant has been approved to create a community planting area.

A new pocket park at top of the village near the roundabout has been installed

Street Surgery – Church Hill and Prospect bend and issues at top of the village.

Unfortunate delays with pothole machine so programme is little behind.

Continuing funding for imagination library free books for 0-5 year olds.

Work still ongoing with allotments space – hopefully by January will have a layout

Pop Up Vaccinations Clinic – Tues 6 Dec at the Angel Brigg

Brigg Xmas Lights Friday 25th and Scunthorpe switch on 26th Dec.
