Chairperson of Barnetby Central Bowls – Presented an item on behalf of Barnetby Central Bowls Neighbourhood Watch Rep – J Munn – Theft from a container, updated from Neighbourhood watch, dangerous motorcycle / nuisance off road motorcycles putting lives at risk.

Raising Awareness of unwanted door to door sales – at the weekend door knockers were in the village. Wanting to make People aware that items were being sold at inflated prices, how these individual identified themselves was questionable And they were reported to have also undertaken door knocking after dark which can be intimidating to residents.

Resident New bungalows Windsor Way – wished to make a complaint about a development site which is currently being treated like a dumping ground, the area is not secure and this is dangerous for passers by.

Environmental Issues / Tree line ploughed through. No replanted trees. Office Block move – dismantled and buried a caravan – could contaminate skegger beck. No attempt to seal off entrances to stop people walking onto the site, throughout the site. Lots of dumped materials Dead Fox seems suspicious / storage container not secure – habitat for vermin.

NLC Wards officers – pursued with Planning and Environmental health they have been on site today – awaiting Assessment from the Health and Safety Executive. There is still a live planning application so will need to await the decision outcome etc
