# **Public Participation**

Janet Welch – Chair of Barnetby in Bloom gave an update on the group The new perennial planting has been working well and much less watering is needed. There has been gardening on the Railway Street Carole has completed the artworks at War Memorial and Village Hall planters. Thanks have been extended to all watering helpers.

The community boxes have been put to good use by the youth club and under 5s, as well as some residents. A talk on litter around the village has been conducted by Janet at the Youth Club. The Best Kept Village judging will start from Friday this week.

The trees at the field are struggling but getting through, and there has been a big reduction of litter. The front gardens will be judged on Sunday and the presentation will take place at the horticultural event.

Jim Munn – Neighbourhood Watch welcomed PC Steve Parsons and PCSO Kevin Horsefall from Humberside Police to the council and urged anyone with concerns to ask questions.

St Barnabas Rd resident raised the concern of speeding on St. Barnabas and how the speed of cars, especially during evenings, has made it look like a racetrack. PC Parsons suggested using a pro laser to monitor speeding, but it is not always possible to know where to laser. They encouraged people to let them or Jim know if a particular vehicle is a repeat offender.

S Knill mentioned the issue of school road having a 20-mile-per-hour speed limit but it was advised that it is not enforceable.

Cllr Waltham MBE explained that the site is a safety zone, and enforceability is the issue. They are working with Safer Roads Humber to resolve this problem.

Robin Welch Chair of Melton Ross and New Barnetby Parish Council updated on the installation of a notice board at The Gallows site. Elwes Family has agreed to this proposal and Robin has three pieces of the original gallows that can be displayed with the board.

Cllr D Wells suggested using a QR code to allow for additional information

Cllr Waltham MBE also advised to get in touch with NLC Design team to provide assistance with this.

PC Steve Parsons and PCSO Kevin Horsfall updated:

There have been a few changes in the team. At Brigg, there are now four officers and two PCSOs. They are conducting pro-laser operations on Kings Road to catch drivers not wearing seat belts, using mobile phones, or speeding. Recent arrest of a young man who was dealing and using class A and class B drugs has been arrested. The team is continuing their pro-active work using ANPR and Markers to catch offenders. They want to work with the community, not against them, to address issues such as drug use, speeding, and lack of documentation.

In a recent warrant execution in the village, nothing was found.

Regarding parking issues, the team will address them if they are causing a risk to public safety. The responsibility for yellow lines lies with NLC.

The final message was to encourage people to join the My Community Alert. for relevant information and always report suspicious activity by calling 101.

In relation to the current active application on Marsh Lane, North Lincs Council is considering adopting a traveller site in Brigg as part of their local plan. There are a number of ongoing enforcement processes that are being addressed in relation to this site.

The request for double yellow lines at Albert Close and Hillside Crescent will be addressed at the site meeting with Councillor Baker. Additionally, hedges that are overgrowing have been reported, and some houses belonging to ONGO have also been reported.

The council are increasing the fines for littering and fly tipping, in line with the Government giving extra power to Local Authorities.
