Cabinet meeting has recently been held, NLC have doubled the fines for Flytipping and littering

Maximum fine for flytipping will now be £1500 and £200 for littering.

Ongoing work with Humberside Police regarding verge and footpath parking in the village, fines are being issued to those parking illegally. Silver Street was noted as a site where fines have been issued.

Currently we are looking for funding to target hotspots of flytipping and install CCTV.

Request for Bin – embankment.

Village Hall Roof funding NLC ward Cllrs are working with MP Andrew Percy's office to seek out funding and also using Section 106 funding to support this project.

Summer activities the free swimming over the summer saw 6700 attendees and Normanby Hall visitor numbers were 40763 over the summer.

Cllr Broughton asked if the village could have more bins, it was noted that this was previously requested at the subway but refused by NLC due to no space to site. It was also requested if the Dog warden could also patrol the village.

Cllr Knill asked if signage to alter people to the flytipping and littering and the fine associated

Cllr Baker updated on the Silver Street blockage issue when the delivery Lorry is offloading does need to be resolved asap. Cllr Baker also advised that the Lay-by Top of Church Hill is a hotspot for fly-tipping, this lay-by should be removed as serves little purpose other than anti-social behaviour.
