Minutes of the full meeting for Barnetby-le-Wold Parish Council held on Monday 16 October 2023.
 Proceedings held at St Barnabas Church Hall, Barnetby Le Wold.

Public participation

Resident 1 – Raised ongoing issues relating to Silver Street parking, concerns that it could cause danger to road users, pedestrians.

Cllr Bakers – updated that a site visit with NLC Highways and Cllr Waltham MBE had been conducted recently and NLC will be exploring a proposal for a loading bay with a no parking zone and double yellow lines opposite the loading bay – this will ensure that the junction onto Victoria Road remains clear and accessible. Another exploration is to look at resident parking permits, however both options will require extensive consultation with residents.

Resident 2 - Stated that following the Council meeting with Hammond Home representatives no action has been taking in relation to their proposals for Skegger beck.
 The same resident also queried why draft minutes are not published on the Parish Council Website prior to being approved at the following meetings.
 It was agreed to add this to the next agenda for discussion.

2310/004 Ward Councillors Report

- a) To receive North Lincolnshire Council Ward Councillors Report

In relation to Silver Street comments, NLC will be looking at scheme over next 4 / 6 weeks, after which a consultation process will begin, it is possible that the Parish Council can also facilitate a resident discussion during this process.

Prospect bend repairs and Church Hill are still in progress and very much part of NLC Highways Scheme of works.

NLC are challenging a number of the proposed changes for Scunthorpe hospital, North Lincs Health and Wellbeing Board have produced an 8 point action plan and consultation is running until to 5th Jan 23.

Work has started on the community diagnostic hub in Scunthorpe.

New Funding for housing has been announced, energy sustainability a few properties within Barnetby have been earmarked to receive support through this fund.

Cllr Waltham MBE advised he had been made aware of the potential closure of the Barnetby Youth Club and advised that NLC can provide support and Cllr Waltham MBE will ensure contact is made.

From the 1 Nove 2023 the Household Recycling Centres will move to their Winter Hours.

Parish Council Governance Review will be taking place early next year, Parish Council will be consulted with about this process in due course.

Trade Watch Sticker initiatives will be rolled out again to households in the coming weeks.

The two pending planning applications will be followed up on to ensure these are taken to committee asap.

Cllr Hoggard raised concerns about the Care Parking Pay machines at Brigg being updated and no longer accepting cash.

Cllr Waltham MBE confirmed that these will be moving to a card only machine and unfortunately it is due to the cash function being discontinued on new models. The Brigg machines are now requiring to be replaced as they are no longer operating.

Cllr Waltham MBE did stress that the default payment is the 2 hours free in which no card or cash transaction is required.
