Cllr Baker advised issues relating to Potholes, an incident recently of a burst tyre. Cllr N Sherwood recognised the need to invest more in the roads.

Spring is just over the horizon and our thoughts are turning to planting and tending the village boxes and beds as all the green shoots begin to appear. The daffodils are already brightening all our lives, and we have had some sunny days despite the unprecedented amount of rain we have had this winter.

We were delighted to see a number of willing helpers turn up on March 2nd to help with the tree planting on the field. Many thanks to the Co-op for their support and practical assistance, and to all who wielded spades. Many hands certainly made lighter work of the job! The trees are there for the benefit of all, both now and in the future, so it was sad to see that the top had been snapped off the top of one of them. I am hoping it was just an accident. We will be putting up a board with the trees to explain their importance in these times of climate change.

We will be cooperating with the Church to replant the Church Hall beds now the overgrown conifers have been cleared. New plants will be largely donated by those who are splitting and dividing their own perennials and who have spare seeds and bulbs. It is also now possible to see the plants that were already there begin to thrive now they are no longer struggling to survive under the canopy of the conifers.

The group has a meeting on 25th March when we will be sharing plans for 2024. With 3 new members, there should be some fresh ideas.

Neighbourhood Watch – Jim Munn gave the following updates - issue with 2 vehicles, parked up on Kings Road since October, Highlighted to fix my street and a notice has been placed on the vehicle. Got to follow due process if the vehicle is to be removed and crushed. Other vehicles parking on the pavement unless causing an obstruction cannot do much. Reports of fly-tipping Glebe Lane. Clerk to advise – encouraged the use of Fix my street good site.

D Day Working Group – Cllr A Thomas updated that Rev. Lee Gable and veterans asked for their input and they agreed to do a commemoration service for D-Day Saturday 8th June.

The clerk has confirmed the Silver Band for the concert performance.

Cllr Wells updated that the Royal British Legion are doing D-Day pins and wreaths.
